Quotations will be opened internally by the Commission immediately or (3) three days after the closing time referred to in instruction 7 above.

A record of the Quotation Opening stating the name of the bidders, the amount quoted, will be recorded by the Commission and available to any bidder on the MICT Website within three working days of the Opening.

9. Evaluation of Quotations

The Commission shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of price or ownership cost, subject to Margin of Preference where applicable, to determine the lowest evaluated quotation.
